
Sir,

Please refer to this Office letter of even No. dated 19th October, 2019 (Copy Enclosed for ready reference), on the above cited subject. It has been observed that Administrative Department(s) are sending proposals for Administrative Approval (A/A) to Planning and Finance Department(s) before providing Central as well as State Share(s) under CSS. In this respect the following is clarified:

The A/A of Planning and Finance Department(s) is required only in those cases where new commitment of State Government either to provide matching State Share for a new scheme or to provide any additional amount over and above the proportionate matching State Share is required. All such schemes which are under implementation currently with the adequate budgetary provisions and no State funds over and above the matching State Share are required to be provided do not fall under the category of such commitments.


