Minutes of the meeting held under the Chairmanship of the Chief Secretary to the Government of Himachal Pradesh to review the funds of various departments lying in the banks

List of Participants at Annexure-'A'

A meeting was held under the Chairmanship of the Chief Secretary to the GoHP in the Committee Hall of Ellerslie Building to review the status of funds lying in banks of various departments. The information related to funds deposited in bank accounts, details of FDs 25.00 Cr and above and data related to inoperative bank accounts were shared with the respective Administrative Secretaries.

After in depth deliberations with the Principal Secretary (Finance), respective administrative Secretaries and Bankers, the following decisions were taken:-

A. FDs Rs. 25.00 Cr and above

- 1. To take decision on FD(s) of HPSEDC, a meeting will be held under the Chairmanship of Secretary (Finance) to the GoHP.
- 2. To review the funds status of Agriculture University Palampur, Horticulture University Nauni and HP University Summer Hill Shimla which have been kept in shape of FDs or other banks accounts, a meeting will be held under the Chairmanship of Pr. Secretary (Finance).
- 3. Secretary (MPP & Power and NCES) was requested to share detailed information w.r.t. HIMURJA deposits by 5th of May,2025.
- 4. Discussion was also held to align the funds of PSUs with the departmental schemes and decision in this regard has to be taken yet.
- 5. The HPSIDC will provide detailed information of funds by 5th of May,2025.
- 6. As per the information of the Task Force Committee, Education Department has huge amount in FDs/other bank accounts. To utilize these funds a decision was taken to attempt an umbrella scheme or utilize this amount for maintenance and OE purposes in the department. Instructions in this regard will be issued by the FD after receiving a proposal from AD (Education) in 10 days' time.
- 7. Internal meetings may be held by Secretary (Education) with directors of education department taking institutions of district Shimla as pilot study and information be shared by 10th of May,2025.
- 8. The District Mining Fund lying in districts will be utilized in concerned Gram Panchayats for sanctioning developmental works/schemes by the Deputy

- Commissioners in place of Decentralized Planning Programmes, BADP etc. funds. Instructions in this regard will be issued by the Planning Department.
- 9. Information on FDs above Rs. 10.00 Cr and below 25.00 Cr. will also be collected by the Task Force Committee.
- 10.No/less allocation of funds/GIA to those departments/Boards/Corporations will be made which have deposits in shape of FDs as per the information of Task Force Committee.
- 11. A sub Committee of 2-3 officers will be constituted by FD to take decision on TSA/SNA system for the State schemes and Secy. (Animal Husbandry) to the GoHP will also be a member of this committee.
- 12. Discussions on funds of Pollution Control Board and other similar organizations will be held separately.

B. Inoperative Bank Accounts

- Instructions will be issued to the concerned Deputy Commissioners and Sub Divisional Officers (Civil) by the Planning department to make the inoperative bank accounts operative in coordination with the account holders and bankers so that this amount may be deposited immediately into the State government Receipt Head following the laid down procedure.
- 2. Task Force Committee will make a template or make inoperative bank accounts operative in consultation with Lead Bank.

C. Deposit of interest into respective receipt Head of Account.

Information w.r.t. interest amount accrued on bank accounts of various departments will be shared with the respective Administrative Secretaries and they will ensure to deposit the same into the department receipt head of account as per the laid down procedure.
