**1. Functions of the Committee:**

The District Planning, Development, and 20-Point Programme Review Committee will function as the Policy and Planning Council at the district level to give directions to the Administrative and Technical Personnel and, according to approval, oversee the implementation in terms of monitoring and review in respect of developmental schemes/Programmes and 20-Point Programme to be executed at the district level. The Committee will also have the final authority to approve the shelf of schemes/projects under various decentralized planning programmes including the Backward Area Sub Plan. The meeting of the Committee will be held on a quarterly basis as per the date and venue fixed by the Chairman. The recommendations and suggestions of this committee will be sent to all the concerned Heads of Departments for taking appropriate action with a copy to the Planning Department, Himachal Pradesh.

**2. Conditions Governing TA/DA:**

The official/non-official Members shall be entitled for TA/DA as admissible under the rules, in accordance with the instructions, notification issued by the Finance Department from time to time.


