Funding DPRs of MLAs priority schemes under existing grant based programmes of GOI/Externally Aided Projects (EAPs).

Sir,

I am directed to inform that during the current financial year 2016-17 NABARD has allocated Rs. 450 crore to Himachal Pradesh for sanction of projects under RIDF-XXII. Against this normative allocation, DPRs of 111 MLAs priority schemes worth Rs.469.72 crore have been sanctioned so far and there is very limited scope to increase NABARD normative allocation during the current financial year. Besides, there is a restriction for availing loan from NABARD since annual borrowing limit is fixed by GoI under Article 293(3) of the Constitution of India, which is likely to impact further sanction of DPRs submitted to NABARD in the current year.

2. It is further informed that large numbers of MLAs priority projects are pending with NABARD for sanction. NABARD has also requested State Government that projects may not be posed to NABARD in view of large shelf of pending projects.

3. Hon'ble Chief Minister HP had also directed the implementing departments, in the MLAs meetings held on 03rd and 05th February, 2016, to first pose the MLAs priority schemes under existing programmes of Government of India. In view of the above, it is requested that MLA priority projects may first be posed for funding under existing grant based programmes of Government of India or Externally Aided Projects (EAPs) as there is limited scope for sanction of projects from NABARD during current financial year. This issue may also be discussed in the HPC meeting likely to be held in the month of November 2016.
