- BBMIS is nearly complete website of information for Blood Centres and its users.
- Organizers could place request for Voluntary Blood Donation camps via BBMIS. There was no need for organizers to physically visit blood centres for raising the request for organization of VBD Camps.
- Voluntary Blood Donors could also request blood donation in BBMIS and the Approval/Rejection of the same could be done in BBMIS.
- Information of Eligible Blood donors of any group could be obtained in BBMIS.
- Information on availability of blood units in various blood centers can be obtained by clients through BBMIS in emergency situations.

- After blood donation, blood donors received SMS via BBMIS, which raised their motivation & retention as Blood Donor.
 - Voluntary donors can get information of nearby Blood donation Camps.
 - All information about blood centres is available at anytime, anywhere.
 - Information of shifting of blood to other blood centres can be done online.
9. How the Innovation project has benefitted the public? (Max. 100 words)
- Organizers could place request for Voluntary Blood Donation camps via BBMIS. Approval/rejection of same could be done by Blood Centres online. There was no need for Organizers to physically visit Blood Centre for raising the request for organization of VBDC.
 - Voluntary Blood Donors could also request Blood Donation in BBMIS, and the Approval / Rejection of the same could be done in BBMIS.
 - Information of Eligible Blood Donors of any group could be obtained in BBMIS.
 - Information on availability of Blood Units in Various Blood Centres can be obtained by anyone through BBMIS in emergency situations.

 - Quick View of Available Blood units for Cross Match in compliance with FIFO principle as per Blood Centre SOPs.

- Information of Eligible Blood Donors of any group can be obtained in BBMIS.
 - Information on availability of Blood Units in Various Blood Centres can be obtained by Clients through BBMIS in emergency situations.
 - Transparency w.r.t. availability of Blood in Various Blood Centres.
