6. Details of the activities carried out with the State Innovation Fund (Max. 200 words).

The State Innovation fund was sanctioned by the Govt. of HP on dated 28th Jan, 2017. The Director, DIT was consulted for the necessary infrastructure and equipments. Accordingly, the space was identified, got furnished. The proforma invoice from National Information Centre Services Inc., Ministry of Communication & Information Technology, NBCC Tower, Bhikaji Cama Place, New Delhi (NICS) was called. Further, the matter was taken up with Director, DFS for sanction and transfer of funds. On receipt, equipments procured and got installed by the agencies and trial run conducted. As per need, the network connection HIMSWAN got upgraded through Directorate, DIT, Shimla. The complete set-up was made operational and the first expert evidence through Video Conference from RFSL, NR, Dharamshala was deposed in the Ld. Court CJM, Chamba, District Chamba on dated 14.05.2018. The facility is being used for expert testimony, attending to meeting and disseminating forensics.

 - i) To Save the Man Hours in transit to depose expert witness, Time saved thus can be utilized in examining, reporting crime cases.
 - ii) To reduce expenditure on account of TA/DA.
- 8. What are the elements of innovation that were introduced which brought out procedural changes and increased efficiency. Please give a brief:
 - i) The Video Conferencing helped in timely deposing expert evidence in different courts of HP State. Time taken to perform journeys was saved and utilized in lab, thus enabled timely examination and reporting of crime cases.
 - ii) During Covid-19 pandemic and afterwards facility is utilized to attend the meeting with the MHA, GOI, Forensic HQ etc.
 - iii) The facility is also being utilized for delivering online lectures to the law and enforcement agencies and disseminating knowledge to young professionals.
- 9. How the innovation project has benefitted the public?
 - -The Video Conferencing facility enabled early and timely deposing the expert testimony, thus facilitated the trials.
 - -During Covid-19 Pandemic, this facility was also utilized by the Medical Officers of Distt. Kangra to depose the expert testimony.
 - The professionals, who are collecting samples for forensic analysis sensitized by way of online webinar.
