The Governor of Himachal Pradesh is pleased to merge the Plan and Non-Plan expenditure distinction of the State Budget from the Financial Year 2021-22. Consequent upon this merger, State Budget will now be classified as Capital and Revenue Expenditure only and Scheduled Caste Sub-Plan (SCSP), Tribal Area Sub-Plan (TASP), Backward Area Sub-Plan (BASP) and Regional and Decentralized Planning Programme (RDPP) will be renamed as under:-

The Nodal departments of these Development Programmes will ensure to get these changes done from the financial year (2021-22) in the concerned Demand for Grants in consultation with Finance Department.


